Project Title: Schafer Stream Crossing and Pond Project (Lake or Streambed Alteration Agreement No. 1600-2019-0218-R1)

Project Location (include county): The project to be completed is located within the Van Duzen River watershed, approximately 6 miles east southeast of the town of Bridgeville, County of Humboldt, State of California. The project is located in Section 24, T1N, R4E, Humboldt Base and Meridian; in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-250-019; latitude 40.4430 N and longitude 123.6799 W.

Project Description: The project is limited to two encroachments. The first proposed encroachment will upgrade a pond spillway (40.443187 N, 123.68005 W). The second proposed encroachment will decommission a road/stream crossing and remove an existing 24' diameter culvert (40.44319 N, 123.67260 W). Work for these encroachments will include excavation, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
