**SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108**

**Project Title:** Macormic Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2018-0655-R1)

**Project Location:** The project to be completed is located within the Mattole River watershed, approximately 10 miles NW of the town of Redway, County of Humboldt, State of California. The project is located in Section 20, T03S, R02E, Humboldt Base and Meridian; in the Ettersburg U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 221-111-004; latitude 40.19595 N and longitude 123.98515 W at the point of diversion.

**Project Description:** The project is limited to four encroachments. One encroachment is for water diversion from unnamed tributaries to Grindstone Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The three other proposed encroachments are to upgrade failing stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.  
CDFW considered the  mitigated negative declaration /  negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
