Project Title: Simas Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2018-0837-R1)

Project Location: The project to be completed is located within the Trinity River watershed, approximately 10.5 miles S/SW of the town of Willow Creek, County of Humboldt, State of California. The project is located in Section 26, T05N, R04E, Humboldt Base and Meridian; in the Grouse Mountain U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 316-015-006; latitude 40.79348 N and longitude 123.68870 W at the first stream crossing.

Project Description: The project is limited to seven encroachments. The seven proposed encroachments are to decommission stream crossings and restore stream channels. All fill materials in the road prism shall be excavated to match the natural slope of the stream at the inlet and outlet. Stream banks shall be excavated to match the nearest undisturbed section of stream associated with the crossing. Any unconsolidated fill materials shall be end hauled to a stable upland location. Any disturbances shall be seeded with native seed and mulched with weed free straw to a depth of 2-inches. A water bar shall be installed on the upslope sections of road associated with the crossings to prevent hydrological connection.
