**Project Title:** Givins Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2018-0667-R1)

**Project Location:** The project to be completed is located within the Van Duzen River watershed, approximately 2 miles E/SE of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 08, T01N, R05E, Humboldt Base and Meridian; in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 210-221-010; latitude 40.474059 N and longitude 123.633614 W at the point of diversion.

**Project Description:** The project is limited to six encroachments (Table 1). One encroachment is for water diversion from an unnamed tributary to the Van Duzen River. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure. Three encroachments are to upgrade failing and undersized culverts. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. Another encroachment is for improvements to the embankment/fill slope and spillway of an off-stream rainwater fed reservoir that discharges overflow into a stream. The sixth encroachment is to recontour a road-site drainage feature, that discharges into a stream, to confine the flow and prevent diversion and discharge onto an adjacent landslide.

This is to advise that CDFW, acting as in the Lead Agency / in a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
