

Project Title: Good Water Diversion Projects (Lake or Streambed Alteration Agreement No. 1600-2017-0730-R1)

Project Location: The project to be completed is located within the Eel River watershed, approximately 5.25 miles east of the town of Myers Flat, County of Humboldt, State of California. The project is located in Section 19, T02S, R04E, Humboldt Base and Meridian; in the Myers Flat U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Numbers 211-361-006, 211-362-018, 211-362-010, and 211-361-008; latitude 40.2740 N and longitude 123.7732 W at the point of diversion "A".

Project Description: The project is limited to ten encroachments. Four encroachments are for water diversion from unnamed tributaries to the Eel River. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. Five other encroachments are to remove existing water diversions and all associated infrastructure. The last encroachment is to implement improvements to a small pond.

This is to advise that CDFW, acting as \(\subseteq \text{the Lead Agency / \(\omega \) a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
