Project Title: Adams Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2019-0274-R1)

Project Location: The project to be completed is located within the South fork Trinity River watershed, approximately SE miles 2.38 of the town of Janes Place, County of Humboldt, State of California. The project is located in Sections 01 and 2, T04, R04, Humboldt Base and Meridian; in the Grouse Mountain U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 315-042-002, 315-043-001; latitude 40.7629 N and longitude -123.6839 W at the first stream crossing

Project Description: The project is limited to four encroachments (Table 1). The proposed encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
