Project Title: Barrett Stream Crossings (Lake or Streambed Alteration Agreement No. 1600-2018-0829-R1)


Project Location (include county): The project to be completed is located within the Van Duzen River watershed, approximately 5 miles south west of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 14, T1N, R4E, Humboldt Base and Meridian; in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel 210-051-050; latitude 40.4563 N and longitude 123.6913W.

Project Description: The project is limited to 2 encroachments One is to upgrade and replace an undersized culvert and the other is to maintain and monitor a footbridge stream crossing. Work for these encroachments will include excavation, removal of the failing culvert, replacement with new properly sized culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. The footbridge shall be monitored by Permittee during and after high flow events and any signs of bridge or bank failure shall be immediately reported to CDFW. CDFW will conduct a site inspection during the term of the Agreement and may require alteration or removal of the bridge following such evaluation. No instream maintenance (other than hand removal of debris) or modification of the bridge or piers is permitted by this Agreement.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
