Project Title: Hawj Water Diversion, Stream Crossings, and Ponds Project (Lake or Streambed Alteration Agreement No. 1600-2018-0068-R1)

Project Location (include county): The project to be completed is located within Dairy Creek watershed, approximately 6.3 miles south of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 34, T1N, R5E, Humboldt Base and Meridian; in the Dinsmore U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-131-021; latitude 40.4227 N and longitude 123.5927 W at the parcel center.

Project Description: The project is limited to 14 encroachments to Dairy Creek and unnamed tributaries. Two encroachments include water diversion for domestic use, irrigation and fire suppression. Work for the water diversion will include use and maintenance of the water diversion infrastructure. Three encroachments are to upgrade unpermitted pond spillways, two are to remediate grading related sediment discharge issues and the other eight encroachments are to upgrade existing stream crossings. Work will include some or all of the following: excavation, culvert removal, culvert replacement, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
