Project Location: The project to be completed is located within the Eel River watershed, approximately 10.5 miles SE of the town of Garberville, County of Humboldt, State of California. The project is located in Section 21, T05S, R05E, Humboldt Base and Meridian; in the Harris U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 216-026-013; latitude 40.01635 N and longitude 123.62946 W at the point of diversion.

Project Description: The project is limited to eight encroachments. Two encroachments are for water diversion from unnamed tributaries to Tom Long Creek. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The six other proposed encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
