Project Title: Ringo Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2018-0329-R1)

Project Location: The project to be completed is located within the Eel River watershed, approximately 1.7 miles west of the town of Blocksburg, County of Humboldt, State of California. The project is located in Section 24, T02S, R04E, Humboldt Base and Meridian; in the Blocksburg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 217-401-002; latitude 40.2837 N and longitude 123.6757 W at the point of diversion.

Project Description: The project is limited to two encroachments (Table 1). One encroachment is for water diversion from unnamed tributaries to Basin Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The other proposed encroachment is for improvements to an on-stream pond spillway and water diversion from the pond for Cannabis irrigation. Work for the pond encroachment will include excavation, placement with new properly sized spillway, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
