**Project Location:** The project to be completed is located within the Eel River watershed, approximately 4.5 miles S/SE of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 36, T01N, R05E, Humboldt Base and Meridian; in the Dinsmore U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-142-005; latitude 40.4274 N and longitude 123.5696 W at the first stream crossing.

**Project Description:** The project is limited to four encroachments. The proposed encroachments are to upgrade failing and undersized stream crossings.
