**Project Title:** Mavrakis Stream Crossing Project (Lake or Streambed Alteration Agreement No. MEN-08584)

#### PROJECT LOCATION

The project to be completed is located within the Cold Creek watershed, approximately 2 miles northwest of the town of Lakeport, County of Mendocino, State of California. The project is located in Section 2, T15N, R11W, Mendocino Base and Meridian; in the Cow Mountain U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 189-030-15.

#### PROJECT DESCRIPTION

The proposed encroachments is to upgrade an undersized stream crossings. Work for this encroachment will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
