Project Location (include county): The project to be completed is located within the Redwood Creek watershed, approximately 2.4 miles southwest of the town of Briceland, County of Humboldt, State of California. The project is located in Section 22, T4S, R2E, Humboldt Base and Meridian; in the Briceland U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 220-091-011; latitude 40.5456 N and longitude 123.9153 W at the point of diversion (POD).

Project Description: The project is limited to three encroachments. One encroachment is for water diversion from an unnamed tributary to Redwood Creek. Water is proposed to be diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. One proposed encroachment is proposed to install a culvert at a road/stream crossing with no infrastructure. The last encroachment is proposed to decommission a legacy failed stream crossing. Work for these encroachments will include excavation, installation of a single culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
