Project Title: Olea Ponds (Lake or Streambed Alteration Agreement No. 1600-2019-0975-R1)

Project Location (include county): The project to be completed is located within the Salmon Creek watershed, approximately 10 miles north of the town of Garberville, County of Humboldt, State of California. The project is located in Section 24, T3S, R2E, Humboldt Base and Meridian; in the Ettersburg U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The project consists of 2 encroachments: Two hydrologically connected ponds installed in the early 1990's without a Lake and Streambed Alteration Agreement. These ponds are being retroactively permitted.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
