Project Title: Pyhtila Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2019-0332-R1)

Project Location: The project to be completed is located within the Lower Eel River watershed, approximately 7.8 miles NE of the town of Garberville, County of Humboldt, State of California. The project is located in Section 20, T04S, R05E, Humboldt Base and Meridian; in the Harris U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 216-136-006; latitude 40.1065 N and longitude -123.6389 W at first stream crossing.

Project Description: The project is limited to 4 encroachments. Two proposed encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. One proposed encroachment is do decommission a stream crossing and restore the stream channel. The fourth encroachment is to decommission and restore habitats cannabis cultivation areas within stream setbacks.
