Project Title: Salazar Stream Crossing and Pond Project (Lake or Streambed Alteration Agreement No. 1600-2018-0087-R1)

Project Location: The project to be completed is located within the Eel River watershed, approximately 4 miles SE of the town of Bridgeville, County of Humboldt, State of California. The project is located in Section 32, T01N, R04E, Humboldt Base and Meridian; in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 208-321-007; latitude 40.27306 N and longitude 123.67943 W at the stream crossing.

Project Description: The project is limited to two encroachments (Table 1). The first encroachment is to upgrade a failing and undersized stream crossing. Work for this encroachment will include excavation, removal of the failing crossing, replacement with new properly sized crossing, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. The second encroachment is to evaluate the stability of pond embankment and spillway. If present in the pond, invasive species (e.g. bullfrogs) shall be eradicated.
