Project Location (include county): The project is located approximately 15 miles east of the city of Garberville; affecting unnamed tributaries to Chamise Creek, a tributary to Upper Mainstem Eel River in the County of Humboldt, State of California; Section 12, Township 5S, Range 5E; Humboldt Base and Meridian, in the Jewett Rock, Calif. 7.5-minute quadrangle, U.S. Geological Survey (USGS) map.

Project Description: The project consists of 3 encroachments: A Class II watercourse culvert replacement with a 24-inch diameter vented ford and two Class II points of diversion.
