Project Location: The project to be completed is located within the Lower Eel River watershed, approximately 3.3 miles NE of the town of Bridgeville, County of Humboldt, State of California. The project is located in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-022-044 latitude 40.4782 N and longitude -123.7245 W at the point of diversion.

Project Description: The project is limited to two encroachments. One encroachment is for water diversion from Muddy Creek. Water is diverted for domestic use only. Work for the water diversion will include use and maintenance of the water diversion infrastructure consistent with this Agreement. The one other proposed encroachment is to remove a failing culvert stream crossing and install an appropriately designed bridge. Work for this encroachment will include excavation, removal of the failing crossing, replacement with new properly designed bridge, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
