Project Location: The project to be completed is located within the Redwood Creek watershed, approximately 5 miles west of the town of Redway, County of Humboldt, State of California. The project is located in Section 18, T3E, R3E, Humboldt Base and Meridian; in the Briceland U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 220-241-004.

Project Description: The encroachment is for water diversion from Redwood Creek. Water is diverted from a well for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure.
