Project Title: Petrov Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2018-0754-R1)

Project Location: The project to be completed is located within the Mad River watershed, approximately 2.5 miles north of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 28, T02N, R05E, Humboldt Base and Meridian; in the Blake Mountain U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 208-221-006; latitude 40.5291 N and longitude 123.6090 W at the point of diversion.

Project Description: The project is limited to five encroachments. One encroachment is for water diversion from unnamed tributaries to The Mad River. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure. One encroachment is to decommission an on-stream pond and restore the stream area. Three other proposed encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as in the Lead Agency / in a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
