Project Location: The project to be completed is located within Van Duzen River watershed, approximately 2.81 miles southwest of the town of Dinsmore, County of Humboldt, State of California. The project is located in Sections 07, 12, 13, and 18, T1N, R5E & 6E, Humboldt Base and Meridian; in the Dinsmore U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 208-331-007 208-331-009, 208-331-010, 208-331-011, 208-331-012; latitude 40.475374 N and longitude 123.551337 W at the point of diversion (POD, well).

Project Description: The project is limited to 8 encroachments on unnamed tributaries to the Van Duzen River. One encroachment is for water diversion from an existing well for domestic use and irrigation. Work for the water diversion will include use and maintenance in compliance with the measures of this Agreement. The seven other encroachments are to upgrade existing stream crossings. Work for these encroachments will include excavation, culvert removal, culvert replacement, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
