Project Location (include county): The project to be completed is located within the Little Burr Creek watershed, approximately 5.5 miles southeast of the town of Bridgeville, County of Humboldt, State of California. Project Description: The project is limited to eleven encroachments to unnamed tributaries in Little Burr Creek.
