Project Title: Dundas Stream Crossings and Domestic Water Diversion Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-17193-R1)

Project Location (include county): The project is located within the Blue Slide Creek watershed, approximately 7 ½ miles west of the town of Redway, County of Humboldt, State of California; Assessor's Parcel Numbers 221-221-037 and 221-202-028; latitude 40.1515 N and longitude 123.9631 W at the point of diversion (POD).

Project Description: The project is limited to twelve encroachments (Table 1). One encroachment is for water diversion from an unnamed tributary to Blue Slide Creek. Water is diverted for domestic use only. Work for the water diversion will include upgrades to, and use and maintenance of, the water diversion infrastructure consistent with the terms of this Agreement. The eleven other proposed encroachments are to upgrade failing, undersized, or poorly designed stream crossings. Work for these encroachments will include excavation, removal of the existing crossing infrastructure, replacement with new properly designed crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
