Project Title: Fredrick Stream Crossings (Lake or Streambed Alteration Agreement No. 1600-2019-0187-R1)

Project Location (include county): The project to be completed is located within the South Fork Trinity River watershed, approximately 15 miles north east of the town of Bridgeville, County of Humboldt, State of California. The project is located in Section 24, T3N, R5E, Humboldt Base and Meridian; in the Sims Mountain U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcels 317-064-008 and 317-064-007; latitude 40.624 N and longitude 123.559 W and 40.627 N, 123.560 W.

Project Description: The project is limited to 14 encroachments (Table 1). All proposed encroachments are to upgrade or remove failing and undersized culverts. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. Five of the crossings will be decommissioned, and the permittee will restore channel to natural condition.
