Project Title: Tucker Stream Crossing and Water Diversion Project (Lake or Streambed Alteration Agreement No. 1600-2019-0518-R1)

Project Location: The project is located within the Eel River watershed, approximately 3.6 miles E/NE of the town of Garberville, County of Humboldt, State of California; Section 15, T04S, R04E, Humboldt Base and Meridian, in the Harris U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 223-124-009; latitude 40.1171 N and longitude 123.7290W at the point of diversion.

Project Description: The project is limited to two encroachments. One encroachment is for water diversion from an unnamed tributary to Dean Creek. Water is diverted for domestic use only. Work for the water diversion includes use and maintenance of the water diversion infrastructure. The other proposed encroachment is repair work on spillways of a stream impoundment. Work for this encroachment includes excavation, removal of the failing culvert, replacement with new properly sized culvert (upper spillway), stream channel restoration (lower spillway), backfilling and compaction of fill. and rock armoring as necessary to minimize erosion.
