**Project Location (include county):** The project to be completed is located within the Supply Creek watershed, approximately 5.8 miles west northwest of the town of Willow Creek, County of Humboldt, State of California, Assessor's Parcel Number 522-024-001; Latitude 40.981761 N and Longitude 123.729757 W, at the parcel center.

**Project Description:** The project is limited to 17 encroachments on unnamed tributaries to Supply Creek. Sixteen projects are to upgrade failing and undersized stream crossings. The other project is to divert surface water to irrigate cannabis. Work for the stream crossings will include excavation, culvert removal, culvert replacement, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. Work for the water diversion will include installation, use and maintenance of the water diversion infrastructure in compliance with the Agreement.
