Project Title: McMurphy Water Diversion and Onstream Ponds Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-10528-R1)

Project Location (include county): The project is located within the Van Duzen River watershed, approximately 1.3 miles northwest of the town of Dinsmore, County of Humboldt, State of California; Section 5, T1N, R5E, Humboldt Base and Meridian, in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 208-281-032.

Project Description: The project is limited to four encroachments: 1) a spring point of diversion (POD) near the residence is diverted to storage tanks for domestic use. 2) This spring feeds an onstream-reservoir ("Pond 1"). Work will include removal of the berm and culvert at the inlet of the reservoir, and restoration of the stream channel near the inlet. 3) Water flows from "Pond 1" into a second onstream reservoir ("Pond 2"). Permittee diverts water from these reservoirs for the purpose of commercial irrigation. 4). A third onstream reservoir ("Pond 3") impounds a spring and seep adjacent to a cultivation area. "Pond 3" appears recently reconstructed. CDFW could find no LSAA for this work, nor any water rights associated with this reservoir. Permittee shall render "Pond 3" incapable of storing water and decommission and remediate the reservoir.

This is to advise that CDFW, acting as in the Lead Agency / in a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
