**Project Title:** Hessler Water Diversion and Stream Crossings Project (Streambed Alteration Agreement No. EPIMS-HUM-31287-R1C)

**Project Location:** The project to be completed is located within the Mattole River watershed, approximately 2 miles east of the town of Bridgeville, County of Humboldt, State of California. The project is located in Section 32, T3S, R1E, Humboldt Base and Meridian; in the Honeydew U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 108-033-004 & 108-033-014; latitude 40.1638 N and longitude 124.0898 W at the point of diversion (POD).

**Project Description:** The project is limited to two encroachments. One encroachment is for water diversion from an unnamed tributary to Honeydew Creek. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure. One encroachment is to upgrade an outfall from a sediment catch basin and drainage ditch to prevent sediment from entering the stream.
