Project Title: Airway Community Care (Lake or Streambed Alteration Agreement No. EPIMS-SON-32773-R3)

**Project Location (Sonoma):** The project is located at Piner Creek, in the County of Sonoma, State of California; Latitude 38.481449, Longitude -122.738940; US Geologic Survey Santa Rosa quadrangle; 3731 Airway Drive, Santa Rosa, California, 95403; Assessor's Parcel Number 058-011-013-003.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement (EPIMS-SON-32773-R3), pursuant to Fish and Game Code section 1602, to the project Applicant, Pacifica Companies.

The project is limited to the construction of an approximately 60-foot by 13-foot concrete headwall and wingwalls to protect a 5-foot by 7-foot concrete box culvert along a realigned portion of Piner Creek installed under a previous Agreement (Notification Number 1600-2017-0181-R3), which expired on December 31, 2021. The project will involve excavating the existing soil around the box culvert, digging footings and drilling piers, setting support cages, and pouring concrete. Installation of the headwall and wingwalls will result in 0.02 acre of permanent impacts to the bed and bank of Piner Creek. No temporary impacts to the stream will occur. No other activities are covered by this Agreement.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on July 14, 2023, and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

- 1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
- 2. CDFW considered the **Mitigated Negative Declaration** prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
- 3. Mitigation measures were made a condition of CDFW's approval of the project.
- 4. A Mitigation Reporting or Monitoring Plan was not adopted by CDFW for this project.
- 5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
- 6. Findings were not made by CDFW pursuant to California Code of Regulations section 15091.
