Project Title: State Route 210 Mixed Flow Lane Addition Project (California Endangered Species Act Incidental Take Permit No. 2081-2017-062-06 (ITP) Amendment 3)

Project Location (include county): The project is located along an 8.2-mile stretch of State Route 210, between post mile marker R25.0 and R33.2, within the cities of Highland, San Bernardino, and Redlands, and a portion of unincorporated San Bernardino County, State of California.

Project Description: The proposed project involves the widening of the existing segment of State Route 210 from Sterling Avenue to San Bernardino Avenue (6.1 miles between PM R26.3 and R32.4) from four mixed flow lanes (two lanes in each direction) to six mixed flow lanes (three lanes in each direction) with the addition of one mixed flow lane in each direction within the median. This Amendment (Amendment 3) authorizes additional time for the Permittee to complete the Habitat Management Land Acquisition portion of the compensatory mitigation required by the ITP. No changes to the project or impacts will occur as a result of this amendment.

The Project will result in impacts to 8.378 acres of Santa Ana River woollystar (*Eriastrum densifolium* ssp. sanctorum), slender-horned spineflower (*Dodecahema leptoceras*), and San Bernardino kangaroo rat (*Dipodomys merriami parvus*) habitat including temporary impacts to 7.628 acres; the Project will permanently remove 0.75 acres. The project is expected to result in incidental take of Santa Ana River woolly star and slender-horned spineflower, which are designated as endangered species, as well as, San Bernardino kangaroo rat which is a candidate, under the California Endangered Species Act. The ITP referenced above as issued by CDFW authorizes incidental take of species listed under CESA that may occur as a result of Project implementation.
