Project Title: IEUA Facilities Master Plan (Wineville Basin Improvement Project Streambed Alteration Agreement No. 1600-2019-0148-R6)

Project Location: The project is located at Wineville Basin, a tributary to the Santa Ana River. It is bordered by Interstate 15 to the west and E. Francis Street to the southeast, in the County of San Bernardino, State of California; Latitude 34.042514, Longitude -117.545875.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Streambed Alteration Agreement number 1600-2019-0148-R6, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Inland Empire Utilities Agency. The Wineville Improvement Project includes modifications to the existing Wineville Basin to enhance the recharge of stormwater and recycled water. The project consists of: installation of a control gate or valve along the existing low-level outlet piping to manage basin storage levels; a controlled gate mounted along the existing 72-inch outlet pipeline; construction of gate structures or adjustable dam along the spillway outlet to create additional basin volume for storage; grading the basin floor to direct flows to a proposed pump station; placement of 1/4ton rip-rap below existing basin inlets; construction of access raps along existing basin slopes; headwall, wingwalls, concrete spillway, sluice gate, pump station inlet structure and in-take.
