Project Decription (Proposed actions, location, and/or consequences).

The Proposed Project involves implementation of a Water Master Plan (WMP) prepared by the City of Modesto. The City developed the WMP to define the City's long-term water supply and infrastructure needs and guide management of its water service system, which includes the City of Modesto and communities in its sphere of influence (Salida, Del Rio, Empire), and the cities of Grayson and Turlock. The WMP identifies recommended and prioritized capital improvement projects (CIPs) for system-wide implementation needed to deliver safe and reliable water and meet water demand requirements for existing and future City customers through buildout of the City's adopted General Plan. The CIPs proposed in the WMP include new water storage tanks, improvements to existing tanks, new and replacement groundwater wells, groundwater monitoring wells, pump stations, transmission mains, distribution pipelines, supervisory control and data acquisition (SCADA) system upgrade, water quality related studies, wellhead treatment, emergency generators, water system security enhancements, groundwater management, water master plan updates, maintaining and calibrating a hydraulic model of the water system, evaluations of the water system, and water meters for the contiguous water service area and/or outlying water service areas.
