**Project Title:** Lake or Streambed Alteration Agreement No. 1600-2019-0195-R5 for 3700 State Highway 135, Los Alamos, 93440 (CHIPS 18, LLC).

**Project Location:** The project is located at 3700 State Highway 135, Los Alamos, 93440, in the County of Santa Barbara, State of California; Assessor's Parcel Number 099-030-058; Latitude 34.747792°, Longitude -120.313885°.
