# 1 INTRODUCTION

This final environmental impact report (Final EIR) has been prepared by Placer County, as lead agency, in accordance with the requirements of the California Environmental Quality Act (CEQA) and the State CEQA Guidelines (Section 15132). This Final EIR contains responses to comments received on the draft environmental impact report (Draft EIR) on the Sunset Area Plan/Placer Ranch Specific Plan Project. The Final EIR consists of the Draft EIR and this document, which includes comments on the Draft EIR, responses to those comments, and revisions to the Draft EIR.

#### 1.1 BACKGROUND

The Draft EIR contains the following environmental analysis sections:

The County used several methods to solicit input on the Draft EIR, including distribution of a notice of preparation on November 3, 2016, to inform agencies and the general public that an EIR was being prepared and to invite comments on the scope and content of the document. Two public scoping meetings for the EIR were held on November 29, 2016 (first meeting from 3:00 to 5:00 p.m. and second meeting from 6:00 to 8:00 p.m.) at the Western Placer Waste Management Authority Materials Recovery Facility in Roseville, California.

On December 18, 2018, the Draft EIR was released for a 67-day public review and comment period that ended on February 19, 2019. The Draft EIR was submitted to the State Clearinghouse; posted on the County's website (http://www.placer.ca.gov/sunset); and made available at Placer County Planning Services in Auburn, California. In addition, the Draft EIR was distributed directly to public agencies (including potential responsible and trustee agencies), interested parties, and organizations.

A public hearing was held on February 14, 2019, to receive input from agencies and the public on the Draft EIR. The hearing was held during the regular meeting of the Placer County Planning Commission at 10:05 a.m. The hearing was recorded, and a transcript was prepared.

# 1.2 ORGANIZATION OF THIS FINAL EIR

This Final EIR is organized as follows:

▲ Chapter 1, "Introduction," provides an introduction and overview of the Final EIR, describes the background and organization of the Final EIR, and lists all parties who submitted comments on the Draft EIR during the public review period.

- ▲ Chapter 2, "Revisions to the Draft EIR," presents revisions to the Draft EIR text made in response to comments or to amplify, clarify, or make minor modifications or corrections. Changes in the text are signified by strikeouts where text is removed and by underline where text is added.
- ▲ Chapter 3, "Responses to Comments on the Draft EIR," contains copies of the comment letters on the Draft EIR received during the public review period, a copy of the transcript from the February 14, 2019, public hearing, and responses to the comments. Comments received within 1 week of the close of the public review period are also included. The chapter begins with a set of master responses that were prepared to comprehensively respond to multiple comments that raised similar issues. A reference to the master response is provided, where relevant, in responses to individual comments.
- ▲ Chapter 4, "Mitigation Monitoring and Reporting Program," includes a description of the CEQA requirements for monitoring or reporting programs for projects approved by a public agency. In addition, the Mitigation Monitoring and Reporting Program (MMRP) includes all the mitigation measures identified in the Draft EIR for the project, including revisions to mitigation measures as described in Chapter 2 of this Final EIR, along with the party responsible for monitoring implementation of the mitigation measures and the milestones for implementation and monitoring. The intent of the MMRP is to prescribe and enforce the proper and successful implementation of the mitigation measures as identified in the EIR for this project.
- ▲ Chapter 5, "References," identifies the organizations and persons consulted during preparation of this Final EIR and the documents used as sources for the analysis.
- ▲ Chapter 6, "List of Preparers," identifies the lead agency contacts and the preparers of this Final EIR.
