Project Title: Doricko Water Diversion and Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2019-0220-R1)

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 10 miles northwest of the town of Laytonville, County of Mendocino, State of California. The project is located in Section 30, T22N, R16W, Mt. Diablo Base and Meridian; in the Lincoln Ridge U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The project is limited to three (3) encroachments. One encroachment is for water diversion from an unnamed spring, tributary to Jack of Hearts Creek. Water is diverted for irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The two other proposed encroachments are to upgrade undersized culverts. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
