Project Title: Capri Stream Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-MEN-09235-R1)

Project Location (include county): The project to be completed is located within the Russian River watershed, approximately 12 miles southeast of the City of Willits, County of Mendocino, State of California. The project is located in Section 34, T17N, R12W, Mt. Diablo Base and Meridian; in the Redwood Valley U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2019-0937-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Justin Capri. The project is limited to one (1) encroachment. Encroachment 1 is for maintenance of an existing stream crossing culvert. Work for this encroachment may include manual removal of sediment or vegetation, or placement of clean rock as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
