Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 4 miles southeast of the City of Willits, County of Mendocino, State of California. The project is located in Section 26, T18N, R13W, Mt. Diablo Base and Meridian; in the Willits U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-04014-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Dennis Wilburn.

The project is limited to seven (7) encroachments. One (1) encroachment is for maintenance of an existing pond and a 36-inch diameter stream crossing/pond outlet culvert that was previously replaced. Additional work at this location will include installation of an extension "chute" at the culvert outfall, and rip rap, if necessary, to prevent erosion.
