Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2019-0820-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Russell Green.

The project is limited to he project is limited to two encroachments. One encroachment is for water diversion from a "shallow well water system collected from the unnamed tributary" to Davis Creek. Water is diverted to storage for cannabis cultivation, though Permittee states "due to a water quality issue, the water supply is not currently used." Work for the water diversion will include use and maintenance of the water diversion infrastructure in accordance with the terms of this Agreement. The other proposed encroachment is to upgrade the embankment and overspill of an onstream pond. Work for this encroachment will include excavation, removal of the failing crossing, reconstruction of the embankment, outlet and spillway, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
