Project Location (include county): The project to be completed is located within the within the Crawford Creek watershed, approximately 4 miles Northwest of the town of Hopland, County of Mendocino, State of California; Section 3, T13N, R12, Mt. Diablo Base and Meridian, in the Elledge Peak U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-10667-R1C, pursuant to Section 1602 of the Fish and Game Code to Dennis Wilburn.

The project is limited to 2 encroachments. One encroachment is to remove concrete and fencing from an unnamed tributary to Crawford Creek. The other proposed encroachment is to upgrade an undersized reservoir outlet culvert. Work for these encroachments will include excavation, removal of the concrete, replacement with new properly sized outlet, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion and installing a weir and bypass piping
