Project Title: Allbritton Stream Crossings and Pond Removal Project. Lake or Streambed Alteration Agreement No. 1600-2019-0666-R1

Project Location (include county): The project is located within the Tomki Creek watershed, approximately 8.8 miles north of the City of Willits, County of Mendocino, State of California; Section 2, T 19N, R 14W, Mt. Diablo Base and Meridian, in the Longvale U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 037-050-43 & 037-050-53; latitude 39.5347 N and longitude 123.3783 W at the first stream crossing (SC1).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2019-0666-R1, pursuant to Section 1602 of the Fish and Game Code to Michael Allbritton.

The project is limited to five encroachments. Two proposed encroachments are to upgrade undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. One encroachment is to install a rocked ford crossing where an unimproved crossing currently exists.

One encroachment is to remove and decommission an existing stream crossing and to conduct stream restoration and revegetation. Work for this encroachment will include excavation, removal of the stream crossing, excavation of existing fill to match the slope of the stream bank, stream bank stabilization and erosion control as needed, and revegetation with appropriate native plant species.

One encroachment is to remove an existing concrete lined pond in the riparian corridor of a stream channel. The pond has a spillway that flows into waters of the State. Work for this encroachment will include draining the pond with a low pumping rate over two days with an appropriately screened pump, installing erosion control for demolition activities, breaking up the concrete with a jackhammer and removing it from the site, backfilling and compaction of fill with native soil, applying additional erosion control after work is completed, and revegetation with appropriate native plant species.
