Project Location: The project to be completed is located within the Eel River watershed, approximately 2 miles west of the town of Willits, County of Mendocino, State of California. The project is located in Section 23, T18N, R14W, Mt. Diablo Base and Meridian; in the Burbeck U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 038-130-46 and 037-180-87; latitude 39.40268 N and longitude 123.38723 W at the first stream crossing (SC-1).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-29250-R1C, pursuant to Section 1602 of the Fish and Game Code to Richard Casarotti.

The project is limited to three (3) encroachments (Table 1). Two encroachments (SC-1 and SC-2) are to upgrade existing culverts. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. Encroachment 3 is for an existing off-stream pond (Pond 1) which overflows to an unnamed tributary to Broaddus Creek. Water is diverted from Pond 1 for cannabis irrigation.
