Project Title: Diaz Stream Crossings and Remediation Project Lake or Streambed Alteration Agreement No. EPIMS-MEN-29084-R1C

Project Location: The project to be completed is located within the Big-Navarro-Garcia River watershed, approximately 5 miles SE of the town of Comptche, County of Mendocino, State of California. The project is in Section 23, T16N, R15W, Mt. Diablo Base and Meridian; in the Navarro U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 125-280-82; latitude 39.22939 N and longitude 123.50823 W at the first stream crossing (SC-01).

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-29084-R1C, pursuant to Section 1602 of the Fish and Game Code to Octavio Diaz.


This Agreement relies on the Notification materials. The project is limited to two (2) encroachments to upgrade existing culverts (Table 1). Work for Encroachment 1 will include rock armoring at the inlet and outlet of an existing culvert. Work for Encroachment 2 will include excavation, removal of the existing culvert, replacement with a new properly sized culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

The permittee also disclosed a well as a water source for cannabis irrigation, located at 39.23051, -123.50682.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
