Project Location (include county): The project to be completed is located within the Eel River watershed. approximately 2.7 miles northeast of the City of Willits, County of Mendocino, State of California. The project is located in Section 5, T 18N, R 13W, Mt. Diablo Base and Meridian; in the Willits U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 108-050-10; latitude 39.4452 N and longitude 123.3203 W at the first point of diversion.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-MEN-04572-R1C, pursuant to Section 1602 of the Fish and Game Code to Gilbert Cox.

The project is limited to five encroachments. Two encroachments are for water diversion from unnamed tributaries to Berry Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. One encroachment is for the removal of existing water diversion infrastructure.

One encroachment is for maintenance of an existing stream crossing. Work for this encroachment will include regularly clearing the inlet of debris and removing vegetation blocking the inlet.

The final proposed encroachment is use and maintenance of an existing low water crossing. The Notification did not propose application of additional rock armoring. However, to protect fish and wildlife resources, CDFW is including protective measures to improve the crossing and to reduce sediment delivery into the stream. Work for this encroachment shall include improving the crossing and armoring both approaches to the crossing in a manner consistent with conditions 2.41.1 through 2.41.8 and 2.42 of this Agreement.
