Project Title: Wolfe Pond Project (Lake or Streambed Alteration Agreement No. 1600-2017-0841-R1)

Project Location (include county): The project to be completed is located within the Big River watershed, approximately 2 miles northeast of the town of Comptche, County of Mendocino, State of California. The project is located in Section 31, T17N, R15W, Mount Diablo Base and Meridian; in the Comptche U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2017-0841-R1, pursuant to Section 1602 of the Fish and Game Code to Ms. Tamara Wolfe.

The project is limited to one (1) encroachment. One encroachment is for maintenance of an existing pond, and its outfall structure. The pond outlets to an unnamed tributary to Big River. Water is not diverted from the pond for consumptive use. Work will include maintenance of the pond, including work that may be required to comply with this Agreement.

The notification also disclosed two wells as the source of domestic and irrigation water for the property. This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).

CDFW's record related to the Lake or Streambed Alteration Agreement is available to the public for review at CDFW's regional office.
