Project Title: Zainaleain Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2018-0611-R1)

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 10 miles northeast of the town of Covelo, County of Mendocino, State of California. The project is located in Section 27, T23N, 11W, Mount Diablo Base and Meridian; in the Newhouse Ridge U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2018-0611-R1, pursuant to Section 1602 of the Fish and Game Code to Mr. Ary Zainaleain.

The project is limited to one (1) encroachment. Encroachment 1 is for replacement of an undersized, damaged stream crossing culvert. Work for this encroachment will include excavation, removal of the old culvert, replacement with new properly sized culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

The notification also disclosed a well as the source of water for the property.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
