Project Title: Leppert Water Diversion and Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2017-0576-R1)

Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 8 miles southeast of the City of Willits, County of Mendocino, State of California. The project is located in Section 29, T18N, R12W, Mount Diablo Base and Meridian; in the Foster Mountain U.S. Geological Survey 7.5-minute quadrangle.

Project Description: The project is limited to six (6) encroachments. One (1) encroachment is for water diversion from a spring that feeds an unnamed tributary to Cave Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The spring is on an adjacent property; notification states the Permittee has an easement.

One (1) encroachment is for replacement of a crushed 12-inch diameter culvert with a minimum 18-inch diameter culvert.

The four (4) other proposed encroachments are for maintenance of existing culverts, including placement of rock as necessary to prevent erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
