**Project Title:** Chavdarov Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2018-0111-R1)

**Project Location:** The project to be completed is located within the Eel River watershed, approximately 9 miles NE of the town of Laytonville, County of Mendocino, State of California. The project is located in Section 03, T24N, R16W, Mount Diablo Base and Meridian; in the Bell Springs U.S. Geological Survey 7.5-minute quadrangle; Mendocino County Assessor's Parcel Number 011-860-16; latitude 39.96212 N and longitude 123.60623 W at the first stream crossing.

**Project Description:** The project is limited to four encroachments. The four proposed encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
