Project Title: Former Naval Petroleum Reserve No. 1: Remediation of Areas of Concern

Project Location: The Site is located at 28590 Highway 119, northwest of Highway 119 and approximately 25 miles southwest of Bakersfield, California.

County: Kern

Project Applicant: Department of Energy – Office of Petroleum Reserves

Project Description: The Department of Toxic Substances Control (DTSC) approved two Remedy Selection and Statement of Basis Work Plans (RSSBs) for the former Naval Petroleum Reserve No. 1 (NPR-1), California, (hereinafter "the Site"). The two RSSBs are for Area of Concern (AOC) 130. The RSSBs contain proposals to excavate or remediate impacted soil with concentrations of chemicals of concern (COCs) at levels that may pose a risk to human health and the environment. DTSC has regulatory authority to approve this action pursuant to California Health and Safety Code, Chapter 6.5.

As Lead Agency under the California Environmental Quality Act (CEQA), DTSC approved the above-described project on January 24, 2020 and has made the following determinations:

1. The project will not have a significant effect on the environment.
2. A Mitigated Negative Declaration was prepared for this project pursuant to the provisions of CEQA.
3. Mitigation measures were made a condition of project approval.
4. A Statement of Overriding Considerations was not adopted for this project.
5. Findings were made pursuant to the provisions of CEQA.
