The ESDC project will expand space for engineering instruction and fabrication, including a welding area, woodworking equipment, exhaust systems, and instructional spaces. The project will include demolition, hazardous materials removal, infrastructure/utilities, landscaping, mechanical, electrical, plumbing, renovations to an existing ADA accessible ramp, and an outdoor student project plaza of approximately 2,500 square feet.
