**Project Title:** Hart-Haight Diversion Operation and Maintenance (Lake or Streambed Alteration Agreement No. 1600-2016-0314-R1)

**Project Location (include county):** The project is located at Little Shasta River, tributary to the Shasta River in the County of Siskiyou, State of California; Latitude 41.689827, Longitude -122.371178 Decimal Degrees at point of diversion.

**Project Description:** The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2016-0314-R1, pursuant to section 1602 of the Fish and Game Code to the project Applicants, Hart Cattle, Inc. and Cowley Family Ranch.

The Project is limited to operation, maintenance, and repair of the Hart-Haight diversion facilities. Specific covered activities include water diversion; adjusting flow control devices; and hand removal of debris, vegetation, and aggraded sediment potentially interfering with operation of the existing or improved diversion facilities up to 150 feet upstream and downstream of the diversion headgate.

This is to advise that CDFW, acting as the Lead Agency, approved the above described project on June 3, 2019 and has made the following determinations regarding the project:

1. The project will not have a significant effect on the environment.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.
